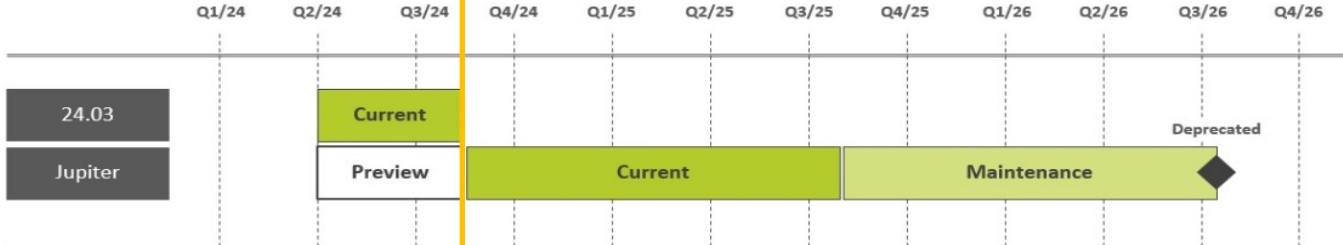
Outlook Certification



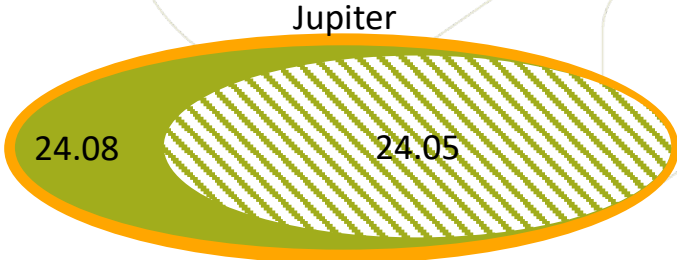
Certification guidelines

- Strict adherence to existing process
- Start of certification period for Release 24.05 on 24.06.2024 and for Release 24.08 on 01.08.2024
- Recommendation to go with Release 24.05 certification and NOT with Release 24.03
- Current: Jupiter Preview (Release 24.03 and 24.05)
- From August: Jupiter Preview (Release 24.03, 24.05 and 24.08)
- From October: Go-live of the Operating Model Jupiter
 - Jupiter is a mix of Release 24.05 and Release 24.08. These releases are provided together and go live together in Jupiter
 - 12th month commitment expires
 - Release 24.03 switched off

Outlook Recertification



Recertification guidelines

- Expiring certificates have to be renewed - full recertification required
- Standards of Release 24.05 and Release 24.08 = Jupiter Preview
 - Where Release 24.08 overwrites Release 24.05, Release 24.05 no longer applies.
 - If anything else changes on Release 24.08, then a self-assessment must be carried out.
- Complete the self-assessment for (re-)certification provided by the association.

Examples and Questions



- **Scenario 1:** I would like to have my solution certified now, for which Release should I get certified?
 - We recommend to go with Release 24.05 certification and NOT with Release 24.03
 - BUT Release 24.08 is missing for Jupiter: So it is necessary to do a self-assessment for Release 24.08 and that would be complete for Jupiter.
- **Scenario 2:** I am certified for Release 24.03, what do i have to do to get certified for Jupiter?
 - Self-assessment
 - BUT Breaking Change: Please note that Release 24.03 will be switched off and it is therefore essential that you adapt your solution, otherwise the solution cannot go live on Jupiter.
- **Scenario 3:** I am certified for Release 24.05, what do I have to do to get certified for Jupiter?
 - Self-assessment
 - BUT Release 24.08 is missing: So it is necessary to do a self-assessment for Release 24.08 and that would be complete for Jupiter.
- **Scenario 4:** The certificate expires on 01. November. For what should I get recertified?
 - For Release 24.08 respectively then for Jupiter
- How do I get my self assessment?
 - Self-assessment is only required when Jupiter is complete (Sep.or Oct.), but the good news is, that no action required right now.
