INTRODUCTION AND PURPOSE

This document is relevant for all partners that want to operate within the Catena-X network. More specifically, this document is intended for the following roles

- Core Service Providers
- Business Application Providers
- Enablement Service Providers
- Business Network Providers
- Consulting Service Providers

It lists the internal (e.g. CX Guidelines) and external (e.g. ISO) standards that a partner needs to fulfil before he/she can offer solutions (services or business apps) in the context of Catena-X. Those standards have been derived from common incoterms in the automotive industry and present the minimal basis so that software can be used within an automotive industry enterprise.

Requesting certain standards from partners secures that all customers that use solutions (services or business apps) are guaranteed a certain level of professionality, security, and trust.

Conformity with the basic standards for the roles listed above is not optional. Without a successful conformity assessment, the onboarding process cannot be completed. It's important to mention, that additionally to the conformity assessment of the partner itself, the solutions will later in the process also need to demonstrate conformity with e.g. use-case specific standards. However, this is not covered here but in the standards for each use-case. This document only deals with the use-case agnostic standards on a partner level.

If you are unsure about your company's role or if you need a general introduction to conformity assessment within Catena-X, please read the Operating Whitepaper.

Conformity, as described in this document, with the basic standards for the roles listed above is not optional. Without a successful conformity assessment, the onboarding process cannot be completed. It's important to mention, that additionally to the conformity assessment of the partner itself, the solutions will later in the process also need to demonstrate conformity with e.g. use-case specific standards. However, this is not covered here but in the standards for each use-case. This document only deals with the use-case agnostic standards on a partner level.

1.3 CONFORMANCE

As well as sections marked as non-normative, all authoring guidelines, diagrams, examples, and notes in this specification are non-normative. Everything else in this specification is normative.

The key words MAY, MUST, MUST NOT, OPTIONAL, RECOMMENDED, REQUIRED, SHOULD and SHOULD NOT in this document are to be interpreted as described in <u>BCP 14</u> [RFC2119] [RFC8174] when, and only when, they appear in all capitals, as shown here.

1.4 PROOF OF CONFORMITY

This section is non-normative

All participants and their solutions will need to prove that they are conform with the Catena-X standards. To validate that the standards are applied correctly, Catena-X employs Conformity Assessment Bodies (CABs). Please refer to the association homepage for the process of conformity assessment and certification.

Conformity with relevant standards during onboarding applies to the participant itself. The participant needs to prove that he follows Catena-X internal (e.g. data sovereignty guidelines) and Catena-X external (e.g. ISO 9001) standards independent of the business applications that he later wants to offer.

For internal standards, a self-assessment that the internal standards are followed shall be conducted by the participant. A statement shall be issued that assures that the internal standards are followed.

Note: As of Release 3.0 there aren't any internal standards that must be followed. This might change with one of the next releases.

For external standards, the existing certificate/prove of conformity with the external standard shall be handed in to the CAB.

The participant can finalize the onboarding only after successful verification of conformity.



2 RELEVANT STANDARDS FOR CONFORMITY DURING ONBOARDING

All requirements that are listed as "mandatory" MUST generally be fulfilled by a participant. If a participant does not fulfill a mandatory requirement, the participant MUST explain why he derives from the requirement. It is then up to the CAB to decide if the participant still receives a certificate.

All requirements that are listed as "optional" SHOULD be fulfilled by a participant.
